All students who are participating in the YUKTI program are advised to strictly follow the guidelines below. Failure to do so could entail strict disciplinary action, including but not limited to suspension of the internship.

- **Registration:** Monday, January 05, 2026, 7.30 am to 8.30 am at the Venue. Students should carry an original government ID and an ID issued by your Law college/institution.
- **Venue:** Dr Ambedkar International Centre, Janpath, New Delhi (<https://share.google/YRKrbSAHeBioAHIDm>).
- **Duration:** Four Weeks, January 05, 2026 to January 30, 2026, essentially Monday to Friday, some Saturdays may also be a working day. A Convocation will be held at the Venue on January 30, 2026.
- **Attendance:** 80% minimum, in all YUKTI sessions.
- **Code of Conduct & Rules:** All students are expected to comply with the Code of Conduct that would apply for YUKTI, the rules that may be applicable by the management of the venue, including the rules and regulations of the organizations that the students would visit as part of YUKTI.

Terms and conditions:

1. Professional Behavior

- Be punctual, attentive, and follow all instructions from coordinators and venue staff.
- Represent your institution with discipline and maturity.
- Be a Brand Ambassador for your Institution.

2. Zero Tolerance for Misconduct

- Harassment (verbal, physical, sexual, psychological).
- Bullying, intimidation, or humiliating behavior.
- Abuse, shouting, rude language.
- Offensive gestures, inappropriate jokes or comments.
- Discrimination on any basis.

3. Respectful Conduct

- Treat peers, speakers, staff, and members of the public politely.
- Maintain decorum: no loud talking, gossiping, or unnecessary disturbance.
- Respect diversity and sensitivity.

4. Classroom/ Public Hall Etiquette

- Keep mobile phones silent.
- Refrain from recording, photography, or videography unless permitted.
- Do not block aisles, disrupt sessions, or mishandle public property.
- Maintain cleanliness; use dustbins.
- Use the facility and infrastructure with care, caution and respect.

5. Communication & Interaction

- Use professional, courteous and parliamentary language.
- Ask questions respectfully and at appropriate times when called for.
- Avoid confrontational or sarcastic behavior.

6. Dress Code

- Business Formals on Monday, Friday and Saturday. Preferably with a formal jacket/suit.
- Business Casuals on Tuesday, Wednesday and Thursday.
- Wear neat, modest attire reflecting your Institution's decorum.
- Slippers / Collarless T Shirts / Sneakers / Shorts, Bermudas/ Short-skirts or a revealing outfit is not an expected Dress Code.

7. Technology and social media

- Bring your devices for YUKTI. GCAI will not provide any hardware support.
- Use devices only for note-taking or permitted academic work.
- Do not post event details, photos, or materials online, without written approval of GCAI.
- Do not share confidential information, without written approval of GCAI.
- AI tools may only be used for non-confidential tasks with prior permission of GCAI.

8. Substance-Free Environment

- No alcohol, drugs, smoking, or vaping and the like during the Internship Period.
- Anyone under any such influence will be removed immediately.

9. Safety & Security

- Follow all safety instructions.
- Report any inappropriate behavior, discomfort, or security concern immediately.
- Take care of personal belongings.

10. Integrity & Accountability

- Be honest about your work, role, and contributions.
- Violations may result in removal from the program and reporting to your institution.

11. Meals and Use of Dining Facilities

- The organizers will provide a welcome breakfast on 5th January only.
- Lunch will be provided by the organisers on all scheduled internship days at designated times and locations within the Venue.
- Students must strictly adhere to the prescribed meal timings and follow instructions issued by the coordinators and Venue management.
- Orderly conduct, discipline, and decorum must be maintained at all times in dining and common areas.
- Students are expected to maintain cleanliness and hygiene and dispose of waste only in designated bins.
- Wastage of food, disorderly behaviour, or misuse of dining facilities may be treated as a violation of the Code of Conduct.
